2 Paystubs & W2s: If your pay is direct deposited into your bank account simply login to your direct deposit account (ask your HR or Payroll representative if you do not have a login) for instant access to all your W2s & paystubs. Download and either email or fax them to us instantly.

☑ Tax Returns: If you use Turbo Tax or other tax software, then open the Turbo Tax application on your computer and print your complete tax returns to .pdf for emailing, or to paper for faxing. Alternatively, if you have an accountant another easy option is to do a quick, 2 minute conference call with your accountant's secretary to authorize them to fax or email us a copy of your return.

Bank Statements: nearly every institution offers online banking and you can easily login and download or print your most recent account statements in just a few short minutes. (Remember to provide ALL pages of each statement)

Mortgage statement: you can easily download or print a copy of your recent mortgage statement by logging into your online account. The most recent statement will show your complete account number and give us important information regarding your escrow balances.

② Home Insurance Declarations page: if you do not have this handy and do not know where to look, call us with what you do know and we will track down your agent and initiate a 2-minute conference with them so you can approve our request for them to fax a copy of your declarations page to us.
